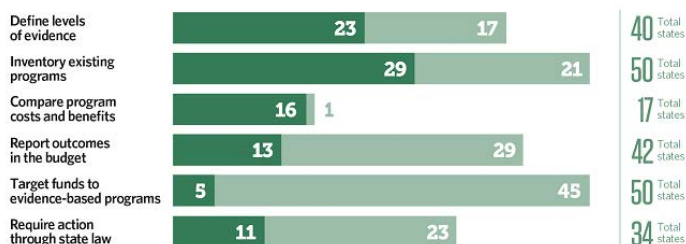
CONNECTICUT ACTIVITY

Connecticut was recently named a leader in the nation in evidence-based policymaking by the Pew-MacArthur Results First Initiative. See the report below, under National-Federal Brief.

The IMRP group has been endeavoring to make updates to the model so that we are always working with the latest Connecticut-sourced information. Recently, we have been focused on updating the Marginal Operating and Capital costs pertaining to Juvenile Justice policy area. Also, we are continually interested in any new submissions or updates to agency program costs which are normally included in each agency's Program Inventory which was last submitted by October 1, 2016.

We continue to hear of interest in the Results First Initiative and evidence-based policymaking and budgeting. The agencies currently involved in this work indicate that this has been helpful in evaluating programs and making decisions on savings and investments. It is expected that this work will serve as a resource to those involved in making policy and budget decisions during the current legislative session.

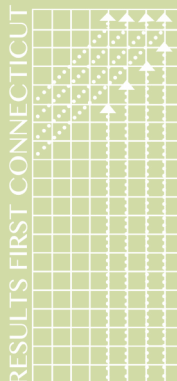
The Pew-MacArthur Results First Initiative has released a new 50-state [study](#) on evidence-based policymaking and has high praise for Connecticut. This report names Connecticut as a leader in the nation due to its legislation requiring “several elements of an effective evidence-based system, including creating tiers of evidence for programs in select agencies and requiring an inventory and cost-benefit analysis of programs in adult and juvenile corrections.” It also cites our experience with Results-Based Accountability as an example of our drive to support policy and budget decisions with program outcome data.

The other states named top 5 leaders are: Washington, Utah, Minnesota and Oregon. Please take a moment to gain some insights from this report.
