MINNESOTA

A very poignant piece on Minnesota's experience with the Results First Initiative was written by the Lieutenant Governor of Minnesota, Tina Smith. In it, she reflects on its two-year-old effort and the success that it has had. Writing in Governing Magazine, she says "This spring our administration is working with the legislature to create a budget for the next two years. It's an exciting opportunity to implement what we've learned through our Result First Initiative. <u>Commission on Evidence-Based</u> <u>Policymaking (CEP)</u>

The CEP has held all the meetings and hearings that it plans to hold. No further public meetings are scheduled. The CEP will be discussing what it has learned and focusing on writing its report which is due to be published in September 2017. The commission was established by the bipartisan **Evidence-Based Policymaking Commission** Act of 2016 (P.L. 114-140), jointly sponsored by Speaker Paul Ryan (R-WI) and Senator Patty Murray (D-WA), and signed by President Barack Obama on March 30, 2016. The Commission is composed of 15 members, appointed by the President, the Speaker of the House, the House Minority Leader, the Senate Majority Leader, and the Senate Minority Leader. Members include individuals with experience as academic researchers, data experts, program administrators, and privacy experts.
